- All day visitors, including Friends, must sign the hiking register before setting off on their walk in the reserve on every visit. It is vital for us to know who is on the reserve at any time in case of an emergency.
- Entry is for the named person only. The card is not transferable. Any accompanying persons need to pay the daily conservation fee (currently R40 per adult, R20 per child).

- We reserve the right to close the reserve to day visitors or to charge extra on particular activity days should the need require.
